

# PERMIT APPLICATION INSTRUCTIONS

1. Only one permit application per person.
2. Permit application is for 1 year only.
3. Issuance fee is \$35.00.
4. Under 19 years of age must have a parent or guardian apply for application.
5. Fully read Application and General Release.
6. Print and fill-out application. Bring original signed copy with payment to the park office.
7. Make copies for your records. Annual permit card will be provided for proof of permit. Cards may be picked up at the park office. Must provide proof if asked by park attendant.
8. Applications will be accepted only from [www.blountcountypark.com](http://www.blountcountypark.com) or park office.

# PARK PERMIT APPLICATION

It is understood and agreed by the acceptance of this PERMIT by the Holder, that the County does not assume any responsibility for loss, damage, or injury, which might be suffered by any person, firm, or legal entity, and that the Holder of this PERMIT accepts and assumes any risks inherent in their use of the facilities of this PARK, and liability for the same is hereby expressly denied.
3. I fully understand and agree to obey all laws and abide by all Park Rules and Regulations while in the Park.
4. **I fully understand that the Park is a natural setting and that there are extremely high and dangerous rock formations located within the boundaries of the Park, and that the engaging of any activity upon or around such rock formations, such as walking, hiking, climbing, and/or rappelling is extremely hazardous and dangerous, and that the participation in any such activity by anyone assumes full risk and responsibility for injury, damage to property, or loss of limb or life. Therefore, I understand and agree to assume any and all risk and responsibility for injury and /or death while engaging in any activity while at the Park.**
5. I fully understand that, although the PERMIT may be granted for multiple days, it is operable only during the hours that the Park is open to the public. Furthermore, I understand and agree that the PERMIT may be revoked at any time and for any reason.
6. I have fully read and understand the GENERAL RELEASE on page 2 of this Application.
7. I am over the age of nineteen (19) and am otherwise fully and legally competent to apply for this PERMIT.

## GENERAL RELEASE

In consideration of **Blount County**, the Blount County Commission, its members, its successors, its employees, and/or the Blount County Park Board, granting a permit to conduct and/or engage in camping, hiking, climbing and/or rappelling activity from Palisades Park, the receipt of which is hereby acknowledged, I agree as follows:

1. I fully understand that there are extremely high and dangerous rock formations located within the boundaries of Palisades Park, and that the engaging of any activity upon or around such rock formations, such as walking, hiking, climbing and/or rappelling, is extremely hazardous and dangerous, and that the participation in any such activity by anyone assumes full risk and responsibility for injury, damage to property, or loss of limb or life.
2. I do, on behalf of myself, my heirs, executors, administrators, and assigns, hereby fully discharge and release Blount County, the Blount County Commission, its members, its successors, its employees, and the Blount County Park Board, from all rights, claims, and actions which I and my above mentioned successors now have or may have against Blount County and its successors arising out of or in any way connected with the granting of this permit to conduct and/or engage in camping, hiking, climbing and/or rappelling activities at Palisades Park which permit was granted to me on this date.
3. This release is intended by the parties to release all claims for money, damage or losses to me (and/or my successors), whether known, unknown, foreseen, unforeseen, patent or latent, which I may have against Blount County, the Blount County Commission, its members, its successors, its employees, and/or the Blount County Park Board, in any way related to or in any way connected with the granting of the permit to conduct and/or engage in camping, hiking, climbing and/or rappelling activities at Palisades Park. I understand and acknowledge the significance and consequences of such specific intention to release all claims and hereby assume full responsibility for any damages or losses that I may incur while engaging in any activity allowed by the granting of this permit or arising out of or relating to the permit which was granted to me on this date.
4. Failure to obtain a permit, or any other violation of Park rules and regulations may result in a \$25 for the first offense, \$50 for the second offense, and \$100 for the third offense. Serious or repeat violations may also result in suspension of privileges, revocation of permits, and expulsion from the Park.
5. I hereby declare that the terms of this release have been completely read and are fully understood and voluntarily accepted.
