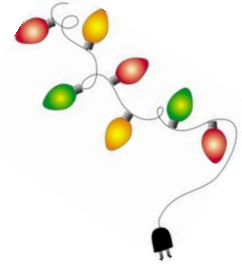




PALISADES PARK CHRISTMAS LIGHTS IN THE PARK



The Palisades Park Christmas Light Event is on display December 1 - 31 from 5:00pm-9:00pm. We look forward to having you participate in this year's event! The Palisades Park Board invites all businesses, churches, families and civic organizations to be part of this Christmas celebration by decorating any available area in the park.

RULES & INFORMATION

- All participants **required** to fill out and sign the registration and agreement form and **return to the park office** by the deadline.
- Registration is open **October 1** thru **November 15**. *Previous year participants may register prior to October 1 to reserve the same area as they had the previous year.* If requesting to change areas, you must wait until October to register and will be on a first come basis.
- Participants are required to reserve an area to decorate. Areas vary in size and depends on the size the participant desires to decorate. Multiple areas together may be reserved for larger displays.
- Palisades Park will display a sign in the reserved area to identify your spot. A **non-refundable \$15 fee** to cover the cost of the sign is required and must be submitted with registration. Signs will be kept in storage at the park after the event for the next season. **There's no charge for signs already in storage.** Participant's not returning to decorate may ask for their sign anytime. Signs that haven't been used in 2 years may be disposed of.
- All entries are **required** to decorate with Christmas lights and/or a Christmas display to fill the area you reserve or a minimum of 15'x15' display.
- The Palisades Park Board approves all displays. Banners and/or signs are allowed and must have a Christmas related theme.
Political signs & banners are not allowed. Requests to hand out literature and/or refreshments require approval from the Palisades Park Board.
- Decorating begins **November 1** and must be completed by **November 30**. The park will be closed on Thanksgiving day.
- When decorating park facilities, participant must make arrangements with the park attendant so it doesn't interfere with any reservations.
- Displays need to be tied down and secure from high winds. Christmas trees must be staked and tied to keep from falling over.

RULES & INFORMATION *continued*

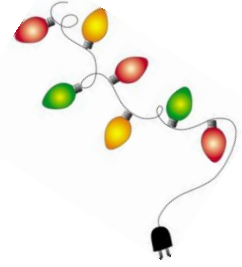
- Participants must check on their displays periodically. It's recommended to visit at least once a week.
- Participants provide their own displays, lights, extension cords, tools & any electrical adapters needed for their area.
- Electricity is available at each area, although, some areas need to share base plugs. Report electrical issues to the park office. Palisades Park provides assistants on electrical issues when staff is available. The supply of power may be limited if there's a possibility of an overload and/or a safety issue.
- Palisades Park will be responsible for turning on and off the lights each night.
- All entries are entered in the Christmas display judging. The categories are Business, Civic Group, Church and Individual. Prize money is awarded. Judging is held within the first week of December and winners posted to the park's website.
- All decorations must be removed within 2 weeks after January 1, weather permitting, but no later than January 31. The area must be left **cleaned** and all trash & debris removed. Any items left after January 31 will become property of Palisades Park and may be disposed of without further notice. If there's a conflict with park reservations, participant may be notified to remove decorations sooner.
